Dear Grand Canyon Staff,

I am writing to share with you that, this week, the Department of the Interior's Office of Inspector General (OIG) opened an investigation into allegations against the [Grand Canyon National Park](#) Superintendent.

The National Park Service always appreciates the Department of the Interior's Office of Inspector General (OIG) for conducting thorough and impartial reviews of allegations like this, and I encourage you all to speak to the OIG investigators on the ground, if you have information that you wish to share with them.

In order to protect the integrity of the OIG's investigation into these allegations, the Grand Canyon superintendent will move temporarily into a position outside of the park while the investigation is conducted. For now, Grand Canyon deputy superintendents will continue to serve as acting superintendent in accordance with their normal rotation.

Once the Office of Inspector General completes its investigation, the National Park Service will determine appropriate next steps, based on the outcome of the OIG's work. We will ensure that all park staff receive regular information associated with this process.

IMR Regional Spokesperson Vanessa Lacayo will be the lead for all media responses on this issue. Any park or regional staff approached for official NPS comment on the OIG investigation are directed to refer the media to vanessa_lacayo@nps.gov or [303-969-2062](tel:303-969-2062).
